Cancellation rules for Inter Caste bookings

| Sr | Cancelled Facility | Cancellation Charges |
|-----------|--|-----------------------------|
| 1. | Wing No.1, Ground No. 2,3,4,6,7 before 30 days booking | 20% |
| 2. | Wing No.1, Ground No. 2,3,4,6,7 before 21 days booking | 30% |
| 3. | Wing No.1, Ground No. 2,3,4,6,7 before 15 days booking | 50% |
| 4. | Wing No.1, Ground No. 2,3,4,6,7 before 8 days booking | 100% |

Note –

- As per above mentioned property booking for wing no. 1 will be done before 30 days and other ground and party plots will be booked before 180 days.
- As per government rules GST will be charged on above mentioned Nakara.
